# Notes to Financial Statement Year ending 31 July, 2003

## 1. General

The Dutch Business Club Korea (the "DBCK") held her first general membership meeting in February 2001. In 2001 the DBCK has initiated the creation of statutes that were approved by the members during that same general membership meeting.

Under the DBCK statutes, the board is to present an annual statement at the end of the activities year for approval by the members in June before the summer holidays. This time the meeting is after the year closing. As member is considered: every person registered as member at the start of the activity year and that has fulfilled related duties (paid membership fee).

Herewith the result of the year 2003/2004, starting July 1, 2003 until and including August 31, 2004.

# 2. Accounting policies

As per statutes, it is the objective of the Board of the DBCK to cover all activities and expenses by membership fees or contributions to specific activities during the same accounting year. A positive balance at the end of the year taken forward into the next bookyear and be used to finance future activities of the DBCK.

The DBCK is a club by and for its members. As a club as the DBCK accept no liability for any costs resulting from acts or mis-behaviour of members. Therefore no reservations nore insurance for these matters have been accounted for.

#### Annual subscriptions and participation fees

The result in year 2003/2004 decreased slightly: in total KRW 5.500.000 subscriptions with a total membership count of 59 (55 paying members). All memberships were collected. Each company or private member is liable for a subscription fee of KRW 100.000. Company with three or more members will pay KRW 300.000 per year.

#### Activities

The DBCK had a very active year. The total cash balance was KRW 45,342,720 (more than double that of previous years). Some of the activities:

- Ken Wells's presentation on North Korea (September 1, 2003)
- > Cheju weekend together with the Hamel Club (September 26, 2003)
- LG Phillips presentation (December 3, 2003)
- Zegna clothing presentation (February 4, 2004)
- Bird flu presentation (February 26, 2004)
- Dutch Golf Open (May 24, 2004)

The Board has held three Board Lunch Meetings, which are accounted for in the cash balance. In addition farewells for the previous board Jeroen, Rein, Albrecht and ambassador the Vries were special expenses this year.

#### Interest and banking costs

KRW 19,544 interest was received over the accounted amount since receivables have been held in cash and in a saving account. Banking costs amounted to a total of KRW 15,880.
