Notes to Financial Statement Year ending 20 July, 2012

1. General

The Dutch Business Council Korea (the "DBCK"), formerly known as Dutch Business Club Korea, held her first general membership meeting in February 2001. In 2001 the DBCK has initiated the creation of statutes that were approved by the members during that same general membership meeting.

Under the DBCK statutes, the board is to present an annual statement at the end of the activities year to its members in July before the summer holidays. The underlying report was discussed by the DBCK Board on Aug 31st, 2012 and shared with all members electronically on Sep 10th, 2012. Additionally, it was posted on the website (www.dbckkorea.com) on Sep 10th, 2012.

As per July 1st, the Board of DBCK currently consists of Marjo Crompvoets (Dutch Embassy), Michiel de Jongh (Monsanto), Jeroen Plag (ING) and JanArie Smit (Heineken), and Heejeong Kim, secretary (Dutch Embassy). Both Michiel de Jongh and Jeroen Plag will leave the Board, with Jan Arie Smit taking over as Chairman while new Board members Ard van Hoof (Vopak) and Simon Scholte (KLM) will join per July 1st, 2012.

We hereby would like to thank Michiel de Jongh and Jeroen Plag for their active participation and involvement during 2011/12 as Board Members as well.

Please find below the results of the year 2011/2012, starting July 15th, 2011 until and including July 20th, 2012.

2. Accounting policies

As per statutes, it is the objective of the Board of the DBCK to cover all activities and expenses by membership fees or contributions to specific activities during the same accounting year. A positive balance at the end of the year taken forward into the next book year and be used to finance future activities of the DBCK.

As per the annual report over the period 2010/2011, the balance of the account amounted to KRW 15,698,686 on July 15th in the Shinhan Bank account in the name of DBCK.

More details regarding the DBCK Shinhan Bank statement, which was opened on 2 September 2010, can be found hereafter. As per the transfer of Chairmanship, a new bank account was opened and the balance of KRW 16.985.340 was transferred per Jul 20th, 2012, closing out the Shinhan account.

During 2012, the DBCK affiliated with the InterChamber (IC) organization. The IC comprises of various international Chambers of Commerce in Korea under the leadership of the International Affairs Department of the Korea Chamber of Commerce and Industry (KCCI). The IC organizes at least two events a year, one business trip and one career forum. Via the IC, the DBCK strives to offer its membership and even larger scope of events and connections with the international network of the various Chambers of Commerce in Korea. One of the Board members of DBCK will attend the IC meetings and report back to the DBCK Board.

Annual subscriptions and participation fees

Membership fee income in year 2011/2012 totaled KRW 8,475,000 from a total of 66 paying members. Each company or private member is liable for a subscription fee of KRW 150.000, with a maximum of 5 paying members per company. A special fee for students is KRW 75,000.

The Board has held 6 Board Meetings, consisting of lunches and farewell dinners, including gifts (Jeroen and Michiel) for departing Board Members, at a total cost of KRW 323.350 (it has to be stated that most lunches were paid by the board members instead of claimed)

Interest and banking costs

Interest of KRW 25,087 interest was received over the accounted amount since receivables have been held in a savings account.


