Notes to Financial Statement Year ending 31 July, 2006

1. General

The Dutch Business Club Korea (the "DBCK") held her first general membership meeting in February 2001. In 2001 the DBCK has initiated the creation of statutes that were approved by the members during that same general membership meeting.

Under the DBCK statutes, the board is to present an annual statement at the end of the activities year for approval by the members in June before the summer holidays. This time the meeting is after the year closing. As member is considered: every person registered as member at the start of the activity year and that has fulfilled related duties (paid membership fee).

Herewith the result of the year 2005/2006, starting Aug 1, 2005 until and including Sept 30, 2006.

2. Accounting policies

As per statutes, it is the objective of the Board of the DBCK to cover all activities and expenses by membership fees or contributions to specific activities during the same accounting year. A positive balance at the end of the year taken forward into the next bookyear and be used to finance future activities of the DBCK.

The DBCK is a club by and for its members. As a club as the DBCK accept no liability for any costs resulting from acts or mis-behaviour of members. Therefore no reservations nor insurance for these matters have been accounted for.

Annual subscriptions and participation fees

The membership fee income in year 2005/2006 increased by 37% to KRW 8,997,000 with a total membership count of 69 (62 paying members). This was mainly due to the increase in membership fee to KRW 150,000. Each company or private member is liable for a subscription fee of KRW 150.000. Company with three or more members will pay KRW 450.000 per year. This season The royal Dutch embassy and ING Life had more than 3 members and were therefore free of charge. All memberships were collected except Maersk, Avebe, Permanento, Hunter Douglas, Incheon Airport, GE consumer finance and ASML. They did not attend any of the meetings either, therefore the board decided to exclude them from the membership list in the 2005/2006 season.

Activities

The DBCK had a very active year with more than 9 activities. New this year was that the DBCK published its first website at www.dbckorea.com and mug book with all members presented.
